Gourmet Liquid Ant Bait-CR will control ants indoors and outdoors. Gourmet Liquid Ant Bait-CR incorporates borax in a special food bait which is highly attractive to ants. Ants pick up the bait and take it to their nests to feed the colony. The borax works slowly to kill all the ants in the colony, usually in about 7 days. For use in homes, apartments, condominiums, schools, boats, cruise ships, hospitals, nursing homes hotels, food processing, food manufacturing, food storage and food service areas, warehouses and other institutional and commercial buildings.

DIRECTIONS: For use without an ant bait station: INDOORS – Sprinkle a few drops of Gourmet Liquid Ant Bait-CR along ant runs and in crevices where they congregate.
OUTDOORS – Place a few drops of Gourmet Liquid Ant Bait-CR on a smooth, firm surface and place on runs and nests.

For use in Ant Bait Stations: Gourmet Liquid Ant Bait-CR may be used in devices that provide entry to ants, but protect the bait from exposure to humans, domestic animals and the elements. The product can be used to fill ant bait stations designed for refilling with bait. Fill bait stations according to manufacturer's instructions. **INDOORS:** Place bait stations 1.5-3.0 meters apart where ants are numerous. Use sufficient bait stations for quick control. Replace traps as needed. **OUTDOORS:** Place bait stations near where ants enter dwellings, and near anthills. Space bait stations according to the volume of the bait station used and the type of ant to be controlled.

Gourmet Liquid Ant Bait-CR may also be diluted with distilled water or other food grade liquid 1:1 to make bait containing 2.7% active ingredient or 2:1 to make a bait containing 1.8% Active Ingredient.

PRECAUTIONS: KEEP OUT OF REACH OF CHILDREN AND DOMESTIC ANIMALS.
Avoid contact with eyes, skin or clothing. Wash hands after use. Avoid contamination of water, foodstuffs and utensils. Wear long-sleeved shirt, long pants and chemical resistant gloves, while mixing, loading or applying product.

FIRST AID:

IF SWALLOWED: Call a poison control centre or doctor **IMMEDIATELY** for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give anything by mouth to an unconscious person.

IF ON SKIN OR CLOTHING: Take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes. Call a poison control centre or doctor for treatment advice **IF**

INHALED: Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible. Call a poison control centre or doctor for further treatment advice.

IF IN EYES: Hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice.

Take the container label or product name and Pest Control Product Registration Number with you when seeking medical attention.

TOXICOLOGICAL INFORMATION: Treat symptomatically.

DISPOSAL:

Thoroughly rinse the empty container. Spread rinsings on soil surface around anthills. Follow provincial instruction for any required additional cleaning of the container prior to its disposal. Make the container unsuitable for further use. Dispose of the container in accordance with provincial requirements. For information on disposal of unused, unwanted product, contact the manufacturer or the provincial regulatory agency. Contact the manufacturer and the provincial regulatory agency in case of a spill, and for clean-up of spills.
